

**TRINITY UNIVERSITY
SPEAKING SERVICES AGREEMENT**

This SPEAKING SERVICES AGREEMENT (this “Agreement”) is entered into effect as of _____, by and between Trinity University, an agency and institution of higher education of the State of Texas (the “UNIVERSITY”) and _____ (the “SPEAKER”).

RECITALS

The University desires to contract with the Speaker for Speaking Services (as defined below), and Speaker, as independent contractor, desires to provide such Speaking Services to the University.

AGREEMENT

In consideration of the premises and the mutual agreements of the parties contained herein, the parties hereby agree as follows:

1. APPOINTMENT AND RELATIONSHIP OF PARTIES

1.1 Engagement. The UNIVERSITY hereby engages the SPEAKER to provide the Speaking Services, and SPEAKER hereby accepts such engagement, pursuant to the terms and conditions contained herein.

1.2 Independent Contractors. SPEAKER shall at all times be an independent contractor as to the University and nothing in this Agreement is intended, nor shall anything be construed, to create between the University and Speaker any relationship of principal and agent, employer and employee, partnership or joint venture, and they shall not represent themselves otherwise.

1.3 Liability for Obligations and Taxes. SPEAKER shall be liable for their own debts, obligations, acts or omissions, including but not limited to the payment of social security taxes, federal, state and city income taxes, workers’ compensation insurance, public liability insurance, and all other required taxes and insurance applicable under existing laws.

2. SPEAKING SERVICES AND COMPENSATION

2.1 Speaking Services. The parties hereto acknowledge and agree that the Speaking Services that are the subject of this Agreement shall consist of the following (the “Speaking Services”):

2.2 Venue of Speaking Services. The parties hereto acknowledge and agree that the Speaking Services shall be performed at _____ (the “Venue”).

2.3 Timing and Compensation. The SPEAKER shall be prepared to perform the Speaking Services at the Venue precisely at _____ on _____, and will speak

through _____, at a flat rate of \$_____ (the “Compensation”). The Compensation shall be paid by the UNIVERSITY to the SPEAKER no later than _____ days after the conclusion of the Speaking Services.

2.4 Tax Exempt Status. Trinity is exempt from Texas Sales & Use Tax for the contracted services in accordance with Section 151.310, *Texas Tax Code*, and Title 34 *Texas Administrative Code* (“TAC”) Section 3.322.

2.5 Inherent Risk. The SPEAKER acknowledges and agrees that they are cognizant of, and shall bear all risk of loss or damage related to, all the inherent dangers and risks involved in the performance of the Speaker Services at the Venue, including but not limited to bodily injury.

2.6 Compliance with Law. The SPEAKER will perform their obligations under this Agreement in compliance with all applicable laws, regulations, ordinances and rules, including, but not limited to, the UNIVERSITY regulations.

2.7 Compliance with University Policies. SPEAKER shall, and shall cause its suppliers, officers, agents, guests, affiliates, or contractors to, at all times comply with all policies, rules and written or unwritten directives of the UNIVERSITY, including but not limited to Alcohol, Drugs, Weapons, Tobacco-Free, and Sexual Misconduct. UNIVERSITY policies may be found at <https://inside.trinity.edu/policies>.

2.8 Permits, Licenses, etc. SPEAKER shall secure, pay for and comply with all permits, licenses and approvals, necessary for proper execution and completion of the Speaking Services. SPEAKER shall provide copies of any permits, licenses or approvals to the UNIVERSITY, upon request by the UNIVERSITY.

2.9 University Facilities.

2.9.1 The UNIVERSITY, in its sole discretion, shall provide passes for SPEAKER’s personnel as necessary to provide access to UNIVERSITY facilities for the performance of the Speaking Services. No other passes will be honored by the UNIVERSITY. SPEAKER shall furnish the UNIVERSITY with a list of all personnel requiring access to the UNIVERSITY’s facilities no later than one (1) week prior to the date.

2.9.2 In the event that passes have not been issued in accordance with Section 2.8.1, the SPEAKER agrees that neither they nor any of their personnel shall access any UNIVERSITY facility unless an authorized representative of the UNIVERSITY is present.

2.10 Filming on Campus. SPEAKER agrees to use any video footage taken on campus only for the purpose(s) intended for this event and should refrain from using video footage of Trinity students or staff without their express permission. SPEAKER agrees that Trinity reserves the right to approve content and use. SPEAKER further agrees that Trinity, in its sole discretion, may instruct SPEAKER to stop recording and/or revoke consent if the content may have a negative impact on Trinity in Trinity’s sole opinion.

3. INSURANCE

3.1 Types of Insurance. Until all of SPEAKER's obligations hereunder have been fully performed, SPEAKER shall maintain, and shall also ensure that each of SPEAKER's subcontractors at every tier employed directly or indirectly by SPEAKER maintains with insurance companies licensed to do business in the State of Texas and that have an A.M. Best rating of A- or better, the types of insurance and with the minimum limits as provided herein.

3.1.1 SPEAKER shall maintain, at their sole cost, general liability insurance, including but not limited to personal and advertising injury, in the amount of at least one million dollars (\$1,000,000) combined single limit for bodily injury and property damage, workers' compensation insurance covering all of the SPEAKER's employees in accordance with statutory benefits and business automobile liability insurance in the amount of at least one million dollars (\$1,000,000). Such insurance shall be in full force and effective at all times SPEAKER and any of their employees, agents, contractors is or are at the Venue.

3.2 Insurance Obligations. The SPEAKER shall submit a Certificates of Insurance with a list of policy forms, endorsements and declarations or, upon request of the UNIVERSITY, certified copies of full policies, acceptable to the UNIVERSITY, at least ten (10) days prior to the commencement of the Speaking Services. All policies shall further contain a waiver of subrogation in favor of the UNIVERSITY, and the UNIVERSITY shall be specifically added and named as an additional insured on all of SPEAKER's insurance policies provided for in this Section 3.

4. TERMINATION

4.1 Termination Without Cause. This Agreement may be terminated upon the mutual written consent of the SPEAKER and the UNIVERSITY. Notwithstanding any provision of this Agreement to the contrary, the UNIVERSITY may terminate this Agreement without cause and without penalty, at any time, upon at least thirty (30) days prior written notice to the SPEAKER.

4.2 Termination for Cause. The UNIVERSITY may terminate this Agreement at any time, effective immediately upon written notice to the SPEAKER, if (i) the SPEAKER defaults in their duties or obligations under this Agreement, (ii) a petition for relief in bankruptcy or reorganization or arrangement is filed by or against the SPEAKER or any affiliate of the SPEAKER, (iii) the UNIVERSITY develops a good faith concern that any provision of the Agreement, or implementation thereof, violates any law, regulation or other applicable authority, or (iv) the UNIVERSITY develops a good faith concern that an act or omission by the SPEAKER is, or could become, a detriment to the students of the UNIVERSITY. The SPEAKER may terminate this Agreement, effective immediately upon written notice to the UNIVERSITY, if the UNIVERSITY defaults in its obligations under this Agreement and the default is not cured within thirty (30) days after receipt by the UNIVERSITY of written notice thereof setting forth the default.

4.3 Force Majeure Event. Notwithstanding anything to the contrary herein, this Agreement may be terminated upon the occurrence of a Force Majeure Event (as defined in Section 7.7).

4.4 Effect of Termination. The termination of the Agreement for any reason shall not affect any right, obligation or liability which has accrued under this Agreement on or before the effective date of such termination. Upon termination of this Agreement for any reason, SPEAKER will cooperate with the UNIVERSITY and do all things reasonably necessary to achieve an efficient

transition of the Speaking Services without detriment to the rights of the UNIVERSITY. Without limiting the foregoing, the SPEAKER will, before receiving final payment of any fees, deliver to the UNIVERSITY or to such person or persons as the UNIVERSITY may direct, all documents, including without limitation, permits, books, records and accounts, insurance policies, files and other materials relating to the UNIVERSITY.

5. INDEMNIFICATION AND LIMITATION OF LIABILITY

5.1 SPEAKER agrees to indemnify, defend, and hold harmless the UNIVERSITY, its trustees, officers, agents, employees, guests and contractors from any and all liabilities, claims, demands, expenses or costs, including attorneys' fees, arising out of any breach by the SPEAKER of the SPEAKER's obligations or representations and warranties under this Agreement, and the acts or omissions of the SPEAKER or any of their suppliers, officers, agents, guests, affiliates, or contractors with respect to providing the Speaking Services contemplated herein. Such right to indemnity under this Agreement shall be in addition to, rather than to the exclusion of, the rights of the UNIVERSITY at law or in equity. This Section shall survive any termination of this Agreement.

5.2 Consequential or Other Damages. In no event will the UNIVERSITY or any of its trustees, officers, agents, employees, guests and contractors be liable to the SPEAKER or any other person or entity for payment of any consequential, incidental, punitive or other special damages arising from a failure to perform its obligations under this Agreement, including but not limited to lost profits.

6. CONFIDENTIAL INFORMATION/SAFEGUARD STANDARD

6.1 Confidential Information. Confidential Information includes but is not limited to information that would be reasonably understood as confidential or proprietary or is designated as such in writing and includes, but is not limited to: confidential personnel information; private health information; student academic information; student financial information (including addresses, phone numbers, bank and credit card account numbers, income and credit histories, and Social Security numbers); credit card information received in the course of business by the UNIVERSITY; information pertaining to the UNIVERSITY'S operations (such as financial and statistical records, strategic plans, internal reports, memos, contracts, peer review information, communications, etc.); and information pertaining to third parties who work with or on behalf of the UNIVERSITY (such as computer programs, client and vendor proprietary information, source code, proprietary technology, etc.).

6.2 Exceptions to Confidential Information. The foregoing restrictions shall not apply to information that the SPEAKER can demonstrate (1) was generally known prior to the date of disclosure of the same to the SPEAKER by the UNIVERSITY; (2) was in the SPEAKER's possession prior to the date of disclosure of the same to the SPEAKER by the UNIVERSITY; (3) becomes generally known through no act or omission by the SPEAKER; (4) is supplied to the SPEAKER, subsequent to the date of disclosure of the same to the SPEAKER by the UNIVERSITY, by a third party not under an obligation of confidentiality with respect to such information; or (5) is required to be disclosed by law or pursuant to an order of a court or other governmental agency of competent jurisdiction, in which case the SPEAKER shall promptly notify the UNIVERSITY of such requirement to afford the Institution an opportunity to prevent or limit such disclosure.

6.3 Confidentiality Policies. As a SPEAKER with access to Confidential Information, the SPEAKER is required to conduct itself in strict conformance with applicable federal and state laws as well as the UNIVERSITY'S policies governing Confidential Information. In that regard, the SPEAKER hereby agrees to use Confidential Information only as needed to perform the specific functions assigned to the SPEAKER, to access Confidential Information only for which it has a need-to-know basis based upon its role, to not in any way divulge, copy, release, sell, loan, review, alter or destroy any Confidential Information except as properly authorized within the scope of the SPEAKER's role, and to not misuse Confidential Information or carelessly handle Confidential Information.

6.4 Criminal Background Check and Credit History. SPEAKER agrees that it will conduct a criminal background check prior to allowing an employee access to UNIVERSITY's Confidential Information and will require the same of any subcontractors, agents, or consultants assigned to do work for the UNIVERSITY and that all employees are obligated to observe covenants of confidentiality. A credit history report is also required for individuals who may be assigned to finance and accounting positions. Any individuals who have criminal or civil convictions related to financial wrongdoing including, but not limited to, embezzlement, fraud, money laundering, theft or others acts indicating dishonesty may not be assigned to the UNIVERSITY if such assignment would involve access to financial information, private personal information, social security numbers, and other confidential or proprietary information.

6.5 Return of Confidential Information. Upon completion of the Speaking Services or upon termination of this Agreement, SPEAKER shall within thirty (30) days, return to the UNIVERSITY or secure return from any subcontractor to the UNIVERSITY, all Confidential Information of the UNIVERSITY without retaining any copies thereof and shall certify the same to the UNIVERSITY in writing within ten (10) days after such completion or termination.

7. NO INFRINGEMENT OR MISAPPROPRIATION

SPEAKER represents and warrants that the Speaking Services to be performed hereunder by SPEAKER will not infringe or misappropriate the intellectual property rights including, without limitation, any patent, trademark, copyright, mask right, trade secret or proprietary know-how of others, and that SPEAKER will indemnify, defend, and hold harmless the UNIVERSITY, its trustees, officers, agents, employees, guests and contractors from any and all liabilities, claims, demands, expenses or costs, including attorneys' fees, arising out of any such infringements or misappropriations. The SPEAKER also represents that they are not bound by any agreement that would be violated by SPEAKER's performance of the Speaking Services or by SPEAKER's fulfillment of their obligations hereunder.

8. MISCELLANEOUS

8.1 No Recording of Performance. No audio or visual recording of the Speaking Services shall be made by either party hereto without the prior mutual written consent of the parties hereto.

8.2 No Waiver. Any failure or delay in the enforcement of the rights detailed in this Agreement by SPEAKER or the UNIVERSITY shall not constitute a waiver of those rights or be deemed a basis for estoppel. Speaker and the University may exercise their rights under this Agreement despite the delay or failure to enforce the rights.

8.3 Notices, Etc. All notices and other communications required or permitted hereunder shall be in writing and shall be mailed by certified or registered mail, postage prepaid, return receipt requested, or delivered by hand, messenger or reputable overnight courier, and shall be deemed given when received at the addresses set forth below, or at such other address furnished in writing to the other parties hereto.

8.4 Paragraph Headings. The paragraph headings used in this Agreement are descriptive only and have no legal force or effect whatsoever.

8.5 Use of Pronouns. The use of the neuter, singular pronoun to refer to a party described in this Agreement shall be deemed a proper reference whether the party is an individual, a partnership, a corporation, or group of two or more individuals. The grammatical changes required to make the provisions of this Agreement applicable to corporations, partnerships, individuals, or groups of individuals, and to females as well as males shall in all instances be assumed as though in case fully expressed.

8.6 Severability. If any provision of this Agreement shall, for any reason, be held to violate any applicable law, and so much of the Agreement is held to be unenforceable, then the invalidity of such a specific provision in this Agreement shall not be held to invalidate any other provisions of this Agreement, which other provisions shall remain in full force and effect unless removal of the invalid provisions destroys the legitimate purposes of this Agreement, in which event this Agreement shall be canceled.

8.7 Force Majeure. Neither party hereto shall be liable or deemed to be in default for any delay or failure in performance under this Agreement or other interruption of service deemed to result, directly or indirectly, from acts of God, civil or military authority, acts of public enemy, war, acts of terrorism, accidents, fires, explosions, earthquakes, floods, failure of transportation, strikes or other work interruptions by either party's employees, or any other similar cause beyond the reasonable control of either party (a "Force Majeure Event").

8.8 Subcontracting and Assignment. The Speaking Services to be performed hereunder are personal to SPEAKER and SPEAKER shall not assign, transfer, or delegate any of their rights, interest or obligations under this Agreement including a subcontract without the UNIVERSITY's prior written consent, which the UNIVERSITY may grant or withhold in its sole and absolute discretion. SPEAKER shall also not collaterally assign this Agreement or any payments due or to become due hereunder without prior written consent of the UNIVERSITY, which the UNIVERSITY may grant or withhold in its sole and absolute discretion.

8.9 Waiver of Subrogation. Notwithstanding anything to the contrary herein, to the extent that any claim herein described is or would be covered by any insurance policies carried or required to be carried by the SPEAKER hereunder, and to the fullest extent permitted by applicable law, SPEAKER hereby waives any and all claims, and releases the UNIVERSITY from any and all liability or responsibility to the SPEAKER or anyone claiming through or under the SPEAKER, by way of subrogation or otherwise, for any (i) loss or damage to any building, structure, or other

tangible property (ii) liability for personal injury or other tortuous conduct, or (iii) losses under workers' compensation laws and benefits, even though such loss, damages, or liability might be caused by the negligence of such party, its agents, contractors, invitees, or employees. Nothing contained herein should be construed as any obligation of the UNIVERSITY to require other parties to waive any rights of subrogation they may possess against or with respect to the SPEAKER.

8.10 Entire Agreement. This Agreement represents the entire agreement by and between the parties, except as otherwise provided in this Agreement, and it may not be changed except by written amendment duly executed by all parties. In the event of a conflict between the terms of the Agreement and any other Exhibits, Attachments, Schedules, Amendments, etc. the terms of this Agreement shall prevail.

8.11 Counterparts. A facsimile, telecopy or other reproduction of this Agreement may be executed by one or more parties hereto, and an executed copy of this Agreement may be delivered by one or more parties hereto by facsimile or similar electronic transmission device pursuant to which the signature of or on behalf of such party can be seen, and such execution and delivery shall be considered valid, binding and effective for all purposes. At the request of any party hereto, all parties hereto agree to execute an original of this Agreement as well as any facsimile, telecopy or other reproduction hereof.

8.12 Governing Law and Venue. This Agreement shall be subject to and governed by the laws of the State of Texas, excluding any conflicts-of-law rule or principle that might refer the construction or interpretation of this Agreement to the laws of another state. Each of the parties hereby consents to the jurisdiction of the state and federal courts in the State of Texas. Venue for its enforcement shall be in Bexar County, Texas.

8.13 Federal Contractor. If applicable, the parties to this Agreement will abide by the requirements of 41 CFR 60-300.5(a). This regulation prohibits discrimination against qualified protected veterans and requires affirmative action by covered prime contractors and subcontractors to employ and advance in employment qualified protected veterans. If applicable, the parties to this Agreement will abide by the requirements of 41 CFR 60-741.5(a). This regulation prohibits discrimination against qualified protected individuals on the basis of disability and requires affirmative action by covered prime contractors and subcontractors to employ and advance in employment qualified individuals with disabilities. The parties hereto incorporate the requirements of 41 CFR 60-1.4(a)(7), 60-300.5(d) and 60-741.5(d), and 29 CFR Part 471, Appendix A to Subpart A, if applicable.
